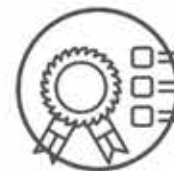

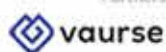

**BFAM TEAM: HOW WILL YOU DESCRIBE THE CAREER PATH YOU CHOSE? AND CAN YOU TELL US ABOUT YOURSELF.**

My career path has been very FULLFILLING with me changing roles almost every 3 years. Mostly within the same business towards upward progression. I believe this has been due to hard work, discipline, and professionalism.

This trend exposed me to many disciplines or work streams that define my HR practices today. God has been good to me, and I have everything to be grateful to Him for.

I have spent over 17 years in national and international-multicultural environments working with C-Suite Executives Directors, and Leaders across the Telecommunications FMCG and Oil & Gas Industries. I am currently in a role of a General Manager, HR and Administration working for a Bulk Oil Storage and Transportation Limited Company (BOST) in Ghana, leading the People Strategy and Agenda.

I plan and implement strategies, budget, policies, and procedures relating to staffing, labour/employee relations, learning and talent development, compensation, change management, organizational effectiveness and HR governance that ensures sustained business growth. As part of Leadership teams, I have managed satisfactory productive meetings between Union Leaders and Management, which has ensured a safe, productive, and engaged workplace.

I am also a shrewd Organizational Psychologist, a Certified Executive Coach, and a Balanced Scorecard Champion. I am happily married with two (2) children – a boy and a girl, a practicing Catholic and a staunch supporter of Asante Kotoko and Manchester United football clubs.

**IF YOU COULD DESCRIBE YOUR HR JOURNEY IN ONE WORD, WHAT WOULD IT BE? WHY WOULD YOU CHOOSE THIS WORD?**

I am passionate about many things. I love spending time with I would describe my HR journey as one of Experiential Learning. As you can see, I am in a new industry (Oil and Gas), and I am still learning.

I have worked for some of the smartest, good, and challenging Managers who also stretched and challenged me at work. ***EMPLOYEE DEVELOPMENT AND TRAINING ARE VITAL FOR ORGANIZATIONAL GROWTH. COULD YOU SHARE SOME OF THE APPROACHES TAKEN BY THE HUMAN RESOURCES DEPARTMENT AT BOST TO ENHANCE EMPLOYEE SKILLS AND COMPETENCIES?***

At BOST, our approach to enhancing employee skills and competencies is anchored on the 70/20/10 model of development. This offers us the opportunity to leverage on various learning interventions including Experiential/ On-the-Job Learning, Relationships (Coaching, Mentorship, Feedback) and formal/classroom/Virtual instructor led learning. In the light of this, capability development interventions are currently focused on Technical Skills, Digital/Data Analytics and Leadership as well as hygiene learning programmes. We have also started the process of certifying some employees working on our key installations, so we have best in class Engineers delivering to add more value to our operations and to the fortunes of the shareholder.

I believe this will be a first in BOST.

***IN WHAT WAYS DOES THE HUMAN RESOURCES DEPARTMENT SUPPORT DIVERSITY AND INCLUSION AT BOST? ARE THERE ANY SPECIFIC PROGRAMS OR POLICIES IN PLACE TO ENSURE A DIVERSE AND INCLUSIVE WORK ENVIRONMENT?***

Diversity and inclusion (D&I) are vital to our success as a business. As testament to the importance BOST places on D&I, we have recently set up the D&I team led by a dedicated manager responsible for Resourcing and D&I within the HR Department. This ensures that D&I is mainstreamed into our business strategy. As part of our D&I initiatives, we have been very intentional in offering female students with engineering backgrounds internship opportunities at our operational sites across the country. We have also supported and partnered the Bost Ladies Association to promote and advance the interest of females within and outside BOST through various Seminars and women empowerment programmes. Additionally, we have in place various policies that ensures all employees and potential employees are given a level playing field when it comes to recruitment and promotions irrespective of once ethnic, religious, political, or other considerations.



**HOW DOES THE HUMAN RESOURCES DEPARTMENT ALIGN WITH THE OVERALL STRATEGIC GOALS AND OBJECTIVES OF BOST? HOW DO HR STRATEGIES CONTRIBUTE TO THE ACHIEVEMENT OF THE COMPANY'S MISSION AND VISION?**

HR in BOST plays a key role in the design and execution of the Business Strategy. This is from our role as an enabler to that of a strategic partner supporting other departments to achieve their strategic objectives. We design and execute the people elements of the BOST Strategy to reflect the short, medium, and long-term plans for realizing the mission and vision of the company.

HR leads in manpower planning including strategies to buy and/or build required capability to deliver the business strategy and the BOST mandate. HR is also at the forefront of creating the conducive environment that foster peaceful industrial relations and engender a high-performance culture. The Performance Management System implemented by HR has contributed significantly to the achievement of the business strategy. In short, the BOST People strategy is a cascaded element from the Business strategy.

There is complete alignment with the business strategy.

**TECHNOLOGY IS RAPIDLY TRANSFORMING HR PRACTICES. HOW IS THE HUMAN RESOURCES DEPARTMENT AT BOST LEVERAGING TECHNOLOGY TO STREAMLINE HR PROCESSES AND ENHANCE EMPLOYEE EXPERIENCES?**

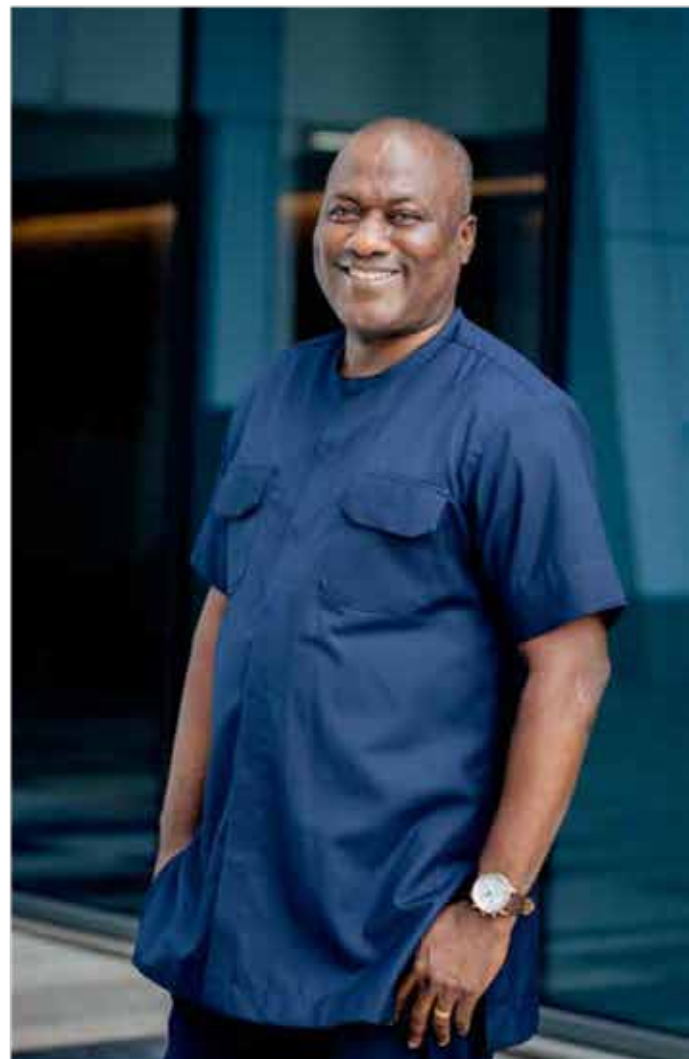

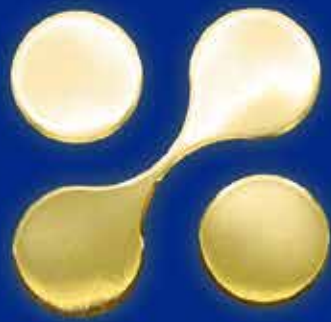

## **NATIONAL LOTTERY AUTHORITY GHANA**

The history of lottery in Ghana can be traced to 1958 when the then Department of National Lotteries (DNL) was established under the National Weekly Lotto Act, 1961 (ACT 94) as a Department under the Ministry of Finance to organize raffles for the public to have fun and win prizes.



With the passage of the National Lotto Act, 2006 (Act 722) the Department of National Lotteries (DNL) gained autonomy. It became known as the National Lottery Authority (NLA), with a sole mandate to regulate, supervise, conduct and manage National Lotto and to provide for related matters. Section 2(4) of Act 722 also empowers NLA to operate Games of Chance and Lottery.

NLA, after the transition, automated its operations by introducing Point of Sale Terminals (POSTs) or automated machines which generate real-time lottery tickets upon purchase. NLA also operates the 5/90 Fixed Odds Game, which has seven different branded products: Monday Special, Lucky Tuesday, Midweek, Fortune Thursday, Friday Bonanza, its flagship product, National Weekly Lotto and the recently introduced Sunday Aseda Draw.

NLA introduced the Caritas Lottery Platform in 2012 to grant opportunities to Commercial and Financial Institutions to run their business promotions through lottery schemes in collaboration with NLA. The Caritas platform is a platform on which lottery schemes are run using a random number generator to draw winners electronically. This fulfils the provisions set in Section 2, (3) of the National Lotto Act, Act 722, to conduct lotteries to support the less privileged in society. Since its introduction, most organizations, especially financial institutions, have partnered with the NLA to enhance their product sales and give back to their cherished and loyal customers as a token of appreciation for their support.

The revenue generated by NLA from this platform has aided in reviving our efforts towards supporting the underprivileged through our Good Causes Foundation.

The Driver and Vehicle Licensing Authority (DVLA) is a public-sector organisation under the Ministry of Transport. It was established in 1999 by an Act of Parliament (Act 569), 1999. DVLA replaced the Vehicle Examination and Licensing Division (VELD). By the Act, DVLA is to provide a regulated framework for an enhanced and more effective administration of drivers and vehicles. DVLA was weaned off government subvention in March, 2016.

Its key stakeholders are the Motor Transport and Traffic Department (MTTD) of Ghana Police Service; Transport Associations; National Road Safety Commission; Ghana National Insurance Commission; Ghana Automobile Distribution Association; Government Technical Training Centre; National Drivers Academy, the Judiciary and the Motoring Public.

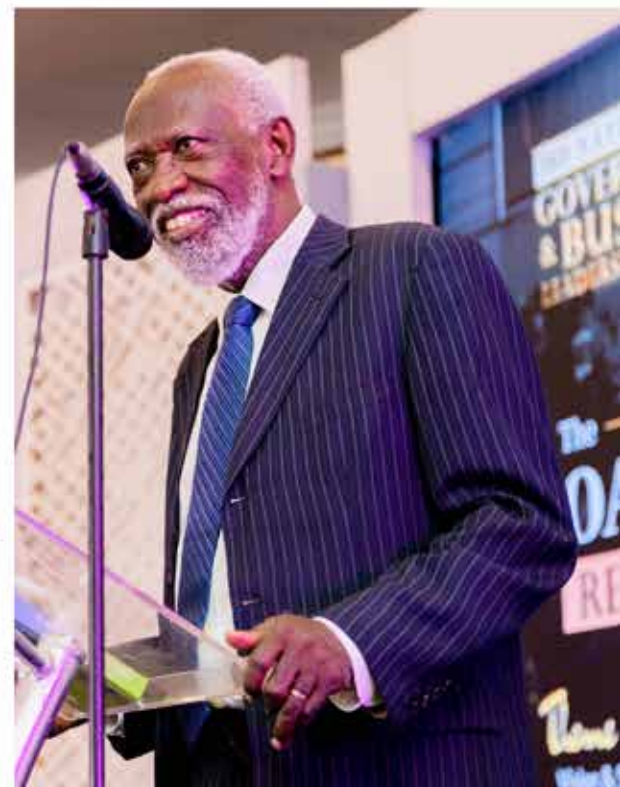
